Prefabricated Ornamental Railing and Its Role in Improving Accessibility within the Built Environment

Stair railing designed for use in public spaces must comply with the Americans with Disabilities Act (ADA). The main concerns with ADA revolve around safety, accessibility, and usability for people with disabilities in public spaces. Universal Design (UD) is a design philosophy that is broader in scope than the requirements of the ADA.
